3. **SCOPE OF WORK:**

4. The contract can be terminated on account of unsatisfactory services upon performance review by the Authority of College of Vocational Studies. The unsatisfactory service shall mean and include non-compliance and non-fulfillment of any of the contractual obligations by the Service Provider and or poor performance and violation of any of the terms and conditions of the tender / contract and failure on its part to correct the discrepancies / shortcomings brought to its notice in writing by the authority of College of Vocational Studies.
5. The quoted rates in percentage [of the project cost] will be inclusive of all charges, applicable Taxes, and no other charges will be paid extra. GST, if applicable, will be paid extra by the College to the concerned Agency / Service Provider on production of receipt by the Agency / Service Provider.
6. The payment to the Agency / Service Provider will be made against running bills on work basis subject to work being satisfactory. All payments shall be made by RTGS / NEFT only.
7. The College shall be at liberty to withhold any of the payments in full or in part subject to recovery of penalties, if any.
8. In case of dispute of any kind, the firm shall abide by the decision of the CVS. In case the dispute is required to be referred to Arbitration, it shall be referred to sole arbitrator under Arbitration and Conciliation Act-1996.
