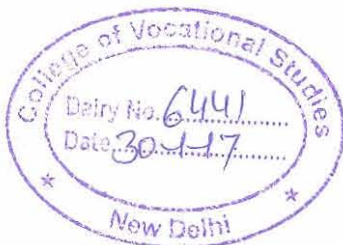
The under mentioned scrap items are to be disposed/written off "AS IS WHERE IS BASIS". With details of terms and conditions as under:-

1. Iron, Wooden, e-waste and Misc. items - 01 lot in 03 different places in the College Campus
2. Ambassador car (M-1999) - 01

Terms and Conditions:-

1. Sealed Bid should be submitted in the name of Principal, College of Vocational Studies, Triveni, Sheikh Sarai, Phase-II, New Delhi-110017, super scribed as 'Quotation for Scraps'.
2. The Bidder must be registered with Metal Scrap Trading Corporation (M.S.T.C), Sales Tax and Income Tax Authority. The bidder should submit self attested copy of the M.S.T.C Registration Certificate and its validity and address proof.
3. The Bidder should clearly mentioned the valid TIN/TAN/Service No./PAN No.
4. Bidder must submit a Demand Draft for Rs.5,000/- (Rupees Five Thousand Only) as Security Deposit amount in the name of Principal, College of Vocational Studies, which will be refunded on the same day i.e. after finalization of the process except the highest 1st, 2nd and 3rd bidders.
5. Last date for submission of bid is 20th February, 2017 till 11:00 A.M.
6. The Bid must be submitted in the Dak Section of the College.
7. The tender will be opened on the same date/day at 2:00 P.M.
8. The Tender will be offered to the highest bidder.
9. Incomplete Bid in any manner/ or submitted after due date would be summarily rejected.
10. The college will not be responsible for any postal delay or delay because of whatsoever reasons may be.
11. The bidder can Physically inspect the scrap till 17th February, 2017 between 10:00 A.M. to 3:00 P.M. on any working day and after that day no inspection will be allowed.
12. The full and final amount of the bid must be deposited by the successful bidder within 24 Hrs. after the bid and lifting of the scrap lots, site must be cleared within two days.
13. The amount has to be deposited in the shape of a Demand Draft drawn in favour of Principal issued by any branch of Canara Bank situated in New Delhi as full and final payment.
14. Tender is valid upto 11:00 am 20.02.2017.
15. Bidder is responsible for labour charges such as for packing and loading, if any.
16. In case the highest bidder will not lift the scraps within stipulated period the earnest money will be forfeited and the next higher bidder will be invited and so on.
17. The College reserves the right to reject any tender and may even cancel the process at any stage without assigning any reason thereof.
18. The college reserves the right to (i) Discontinue/terminate the process at any stage without being liable to any one and assigning any reason; (ii) And Exclude the party from any consideration if the documents/information is not provided as required or incomplete or lacking or the college has sufficient ground that it can go against the college interests at any stage; and (iii) Take the appropriate steps action as warranted from time to time if not satisfied with the work or supplier and delivery of services as per rules in the interest of the college.
