

For given proper coverage and dissemination of the scheme benefits, you are requested to take the following steps:-


1. Setting up a help desk by the Educational Institutes and appoint a Nodal Officer to assist the eligible students to apply online.

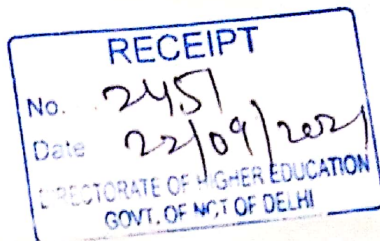


Respected Sir,


