**RULES REGARDING THE CONDUCT OF DUSU AND COLLEGE
STUDENTS' UNION ELECTIONS FOR THE YEAR 2024-2025**

AS PER THE LYGDOH COMMITTEE

Following rules, terms, conditions and "Code of Conduct" issued by the University of Delhi will be strictly adhered for contesting the Students' Union election of the College.

1. Only **3rd year** students shall be eligible to contest for the post of President.
2. The post of Joint Secretary is open only to **1st year** students.
3. Candidates must have passed in the last examination i.e. the examination held immediately before contesting the election.
4. The candidate should have attained the minimum **75 percent attendance**.
5. The candidate shall not have a previous criminal record, that is to say he should not have been tried and / or convicted of any criminal offence or misdemeanour. The candidate shall also not have been subject to any disciplinary action by the university authorities.
6. The candidate must be a regular, full-time student of the College/University and should not be a distance/proximate education student. That is to say that all eligible candidates must be enrolled in a full-time course, the course duration being at least one year.
7. Candidates for the all the posts are required to deposit Rs. 500/- as security deposit (Refundable).
8. The Security deposit shall be forfeited in case a candidate fails to get at least 10% of the total valid votes cast for the post.
9. A candidate withdrawing his/her candidature before the last date fixed for such withdrawal may claim the return of security deposit in person by showing his/her identity card to Mr. Manoj Kumar Sharma, A.O. (Admn.) Room No. 38.
10. The students are not allowed to deface the property of the College with posters / banners / stickers or any such items put up anywhere on College premises.
11. The person whose posters / banners / stickers or any such items are found pasted will be held responsible for it and action will be taken against such person. No excuse will be entertained.
12. No campaigning shall take place after 05:00 p.m. on 25th September 2024.

13. No candidate shall be permitted to make use of printed posters, printed pamphlet, or any other printed material for the purpose of canvassing. Candidates may only utilize handmade posters for the purpose of canvassing, provided that such handmade posters are procured within the expenditure limit of Rs. 5,000/-.
